- 2. <u>Vacancies</u>: Number of vacancies (Division/Unit wise) will be communicated later on.
- **Eligibility Criteria**: As per the Department of Posts' MTS (Group 'C' post) Recruitment Rules, 2018 notified in GSR 781 (E) dated 16.08.2018 and Department of Posts, MTS (Group 'C'post) Recruitment Rules, 2019 notified in G.S.R. 850(E) dated 15.11.2019 (Annexure-II), the following category of GDSs are eligible to appear in the examination:

Gramin Dak Sevaks (GDSs) who have worked regularly for three years in that capacity as on the **01.01.2019**.

- **4.** Educational Qualification: No educational qualification is prescribed for Gramin Dak Sewak, Para 2 Department of Posts, MTS (Group 'C' post) Recruitment Rules, 2019 notified in G.S.R. 850(E) dated 15.11.2019 refers.
- **5. Age limit:** There shall be no upper age limit for Gramin Dak Sevaks.
- **Pattern & Syllabus of Examination**: The examination will be conducted as per the revised pattern and syllabus circulated by Directorate vide letter No. 17-08/2018-SPB-I dated 10.05.2019 under Annexure 'A' read with letter No. 17-08/2018-SPB-I dated 26.06.2019, 28.06.2019, 11.07.2019 & 23.07.2019. Details of Pattern and Syllabus are furnished in **Annexure-III.**
 - a. Candidate must exercise preference for all Recruiting Units (except parent Unit/Division) for consideration in the proforma at Annexure IV.
 - **b.** Order of preference (as per Annexure-IV) once exercised shall not be changed.

7. Centres of Examination:

The examination will be conducted at Circle/Regional Head Quarters. The APS candidates have to appear for the examination from the Regional Centre, to which they belong. The Regional Offices will nominate Centre Supervisors under their control to conduct the examination in their Regional Headquarters under intimation to CO and the nominated officer will conduct the examination under their supervision at Circle/Regional headquarters as per the schedule. The Centre Supervisor nominated by the Circle/Region Office will select venue for the examination and will intimate to Divisional Heads before the schedule date for issue of Admit Card/Hall Permit. Under no circumstances, the candidates will be permitted to appear from other Circle Centres.

- **8.** The applications of the APS candidates should be sent to the concerned Divisions only and not to Circle Office.
- 9. All the Divisional heads are directed for giving wide publicity to this Circular for inviting the Applications from eligible candidates in prescribed form (Annexure I). The Divisional heads/controlling authority has to scrutinize the details furnished in the Applications submitted by the candidates, thoroughly with reference to Name, Date of entry into service, Date of Birth, Age, Educational Qualification, category/community, eligibility criteria etc. with reference to the relevant recruitment rules and service records of the concerned candidate.

G.S.R. 781(E).—In exercise of the powers conferred by the proviso to article 309 of the Constitution and in supersession of the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2015, except as respect to things done or omitted to be done before such supersession, the President hereby makes the following rules regulating the method of recruitment to the post of Multi Tasking Staff in the Department of Posts, namely:-

- Short title and commencement.— (1) These rules may be called the Department of Posts (Multi Tasking Staff) Recruitment Rules, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification and Level in the Pay Matrix.— The number of posts, their classification and the Level in the Pay Matrix attached thereto shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- 3. Method of recruitment, age limit, qualifications, etc.—The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in columns (5) to (13) of the said Schedule.
- Disqualification.— No person,-
 - (a) who has entered into or contracted a marriage with a person having a spouse living; or
 - (b) who, having spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- Requirement to serve in the Army Postal Service.— Any person appointed to the posts specified in the said Schedule shall be liable to serve in the Army Postal Service in India or abroad, as required.
- 6. Power to relax.— Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 7. Saving.— Nothing in these rules shall affect reservations and other concessions required to be provided for the Scheduled Castes, the Scheduled Tribes, ex-servicemen, Other Backward Classes and other special categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.


